Narrative

1-2-07 DCS received a report [REDACTED] indicating Jessica Kline who is now 13 was sexually abused by her Pastor's son when she was 6 or 7.

1-3-07 FCM and Det. Adang met with Terry and Kristine Kline at the WPD. They reported on 9-10-06 Jessie them of the abuse after another adult overheard her talking with a friend. They believe it only happened one time when Jeremy was babysitting. Jessie told them it happened in the basement of their home and she does not remember where [REDACTED] was.

[REDACTED] The Kline's had a meeting with Pastor Lowe. Jeremy is married to Abby and is the Lowe's middle son. Jeremy was called to the mtg. as well and Jeremy admitted to molesting her but didn't admit to exactly what happened. The Kline's advised they want Jeremy to get help. They contacted a counseling ministry in Texas who was to work with both Jessica and Jeremy. Jeremy didn't participate as promised. The FCM asked why the Kline's did not report the sexual abuse. Both indicated they were unaware they had to report and Pastor Lowe did not advise them of such.

Kristine reported Jeremy has no children. Jessica wants the issue to go away. [REDACTED] The Kline's are concerned because Jeremy told them he was sorry Jessie remembered and did not seem to be remorseful that he did it. [REDACTED]

[REDACTED] Jeremy only babysat maybe 3 times for the children. There was no reason they stopped using him. The kids have recently complained about the school and they are now at Lakeland Christian Academy.

1-4-07 FCM interviewed Jessica at WPD while Det. Adang observed. [REDACTED] The FCM was forced to ask Jessica direct questions. Jessica obviously has much shame about the incident and advised the FCM she "wants it all to go away". FCM ascertained that Jeremy kissed Jessica on the lips and put a pillow over her face while he fondled her feet. [REDACTED] Jessica and FCM discussed her need for counseling and FCM spoke with Jessica at length about how to protect herself from further abuse.

The FCM advised both Terry and Kristine that Jessica is a likely victim because her personality is that of a peacekeeper. Both parents indicated they are aware of this and will also work with Jessica on protecting herself. FCM recommended that Jessica participate in counseling with Joe Graham as he can address the religious aspects of the abuse. FCM also recommended Kristine and Terry get some counseling as well. Both parents agreed to continue to prohibit contact.

1-8-07 FCM spoke with Steve Adang who advised he spoke with Jeremy. Jeremy admitted to Adang that he kissed Jessica and had her lay on top of him. Jeremy also admitted to covering her face with a pillow and being aroused by her feet. FCM advised Adang the witnesses have interviews scheduled.

[REDACTED] reported that approximately one year ago Jessica told [REDACTED] Jeremy had French kissed her. [REDACTED] thought it strange but feels Jeremy is strange so didn't think much about it. Jessica didn't offer any other details and the discussion was brief. [REDACTED] feels Jessica told her about the kissing that day because [REDACTED] had questioned why Jessica did not like Jeremy.

A few months ago the girls were at a birthday party and [REDACTED] was upset with Jessica. [REDACTED] told [REDACTED] that Jessie is going through things and [REDACTED] should not be upset with her. [REDACTED] asked what Jessie is going through and Melinda overheard that conversation. Melinda told [REDACTED] to tell her what happened between Jessie and Jeremy. Melinda told John Bryan Lowe and Alyssa that Jessica was reporting sexual abuse. Terry and Kristine were alerted and Jessica told that it happened several years ago and only one incident. Melinda believes Jessica told that their clothes were off. [REDACTED] They were alone in the basement together.

Melinda and [REDACTED] reported Jeremy is often inappropriate. [REDACTED] thinks he is perverted and she denied any sexual abuse to her. Melinda will prohibit contact between Jeremy and [REDACTED]

1-19-07 Kristine reported Jessica saw Joe Graham last night. The counseling went well and Joe feels she does not need to continue to see him. They are continuing to prohibit contact and will take Jessie back to see Joe if anything else comes up.

1-29-07 Kristine called FCM and requested a copy of the 311. Kristine advised the FCM the Lowe family called a big meeting this weekend with some of the church members and told lies about what happened. This has been very hurtful. FCM again recommended family counseling.

The report is substantiated based on Jessica's statement and Jeremy's admission. A police report will be forwarded to the

prosecutor. The parents are prohibiting contact and Jessica was referred to counseling. Case is closed.
